Technical Internet standards organisations & Internet Governance bodies (IETF, RIPE, ICANN...) decide on technology built today & used in the future - without considering "Evidence-based climate policies for meeting the international climate goals".

I have been cross-connecting these technical communities with the Climate Justice movements, while facing many obstacles:

- I am neither an academic not an engineer (any more)
- these two groups speak different languages
- both fields are too large

With your help, I want to answer: **How can we minimise the detrimental environmental impact of the Internet?**

What would be different in my project is: taking a higher-level view, and combining with other existing approaches: (such as DeGrowth, Collapsology, Just Transition, Feminist Internet, etc)

My objectives are: to get clarity on the actual environmental impact; give structure to the criteria for taking actions; determine what the focus of the actions should be on short, medium & long term; uncover the gaps in the existing research and produce a list of topics for the future research.

Methods:
